Meeting Minutes

1. Call to Order: Chair Kara Escajeda called the meeting to order at 9:06 a.m.

2. Public Comment: No comments were made from the public.

3. Staff Update:

--John Weber stated that the Vulnerable Road User Ordinance received support from both the Technical Advisory Committee (TAC) and Transportation Planning Policy Board (TPPB) and the ordinance was then sent out to the cities in the KTMPO planning region.

--Mr. Weber informed the members that KTMPO has issued a project call to reprioritize the projects located in the 2040 Metropolitan Transportation Plan (MTP) project listing. Mr. Weber encouraged BPAC members to contact city staff if they would like to see Bike/Pedestrian projects submitted.

--Mr. Weber provided an update on air quality for the month of June. The highest 8-hour average ozone reading at the Temple station was 68 parts per billion and the Killeen station was 67 ppb. The design value, if calculated to date, is 67 ppb at Temple and 66 ppb at Killeen.

4. Action Item: Regarding approval of May 11, 2016 meeting minutes.

Robert Ator made a motion to approve the May 11, 2016 BPAC meeting minutes, seconded by Leo Mantey; the motion passed unanimously.

5. Discussion and Action Item: Prioritize list of possible objectives.

John Weber provided BPAC members with a list of possible objectives and asked members to prioritize them. This list can be altered and changed to address any bicycle/pedestrian issues or programs that may come up in the future. The floor was opened to discussion.

BPAC members decided to combine interconnectivity issues regarding parks/landscape features, identify gaps in the bicycle and pedestrian networks, how to connect bike/pedestrian infrastructure to transit stops, and how to provide landscape buffers for safety concerns into one objective and rank that as the top objective. Bike racks were chosen as the second highest priority followed by the Bike Friendly Business Initiative, Promotional Events, and school safety programs. BPAC asked staff to contact BPAC members who missed today's meeting and ask for their ranking and at the next BPAC meeting the prioritized list will be presented and available for action.

No action was taken on this agenda item.

6. Discussion and Action Item: Identify and recommend locations where bike racks are needed.

John Weber stated that KTMPO staff is asking for a list of preferred bike rack locations in the KTMPO planning region. This list will then go to the Central Texas Air Information and Research (CTAIR) Advisory Committee to assist them in determining appropriate locations for placing bike racks if they choose to fund this project.

Jason Deckman provided a brief demo on how to use the bike/pedestrian web map and asked for suggestions. Jimmie McCormack asked if there was a possibility of putting in a point feature class for "Share the Road" signs. KTMPO staff will look into adding that feature to the web map.

The floor opened to discussion. Possible locations include bus stops, businesses that cater to cyclist, and businesses that provide restrooms and free water. Possible parks include Purser Park and Copperas Cove City Park. Possible businesses include local big box stores and other commercial shopping areas. BPAC members decided that from now until the next meeting, they would use the Bike/Pedestrian Web Map and create a "wish-list" of where they would like to see bike racks. At the next BPAC meeting, KTMPO staff will present a list of recommended bike rack locations to the BPAC and the members may take action if needed.

No action was taken on this item.

7. Other Comments: No comments were made from the BPAC members.

8. Possible Dates and Time for Next Meeting.

The next meeting will be held on Tuesday, September 13, 2016 at 9:00 a.m.

Regarding Approval of Prioritized List of Possible Objectives/Activities

Background:

At the July 12th, 2016 BPAC meetings, KTMPO staff presented a list of possible objectives to pursue that BPAC members provided at previous meetings. The BPAC members prioritized the objectives and asked KTMPO staff to send out the list to the BPAC group to receive any additional feedback on the list.

Resulting Prioritized List of Objectives:

- 1) Identify interconnectivity issues, i.e. parks/landscape features/gaps in the bicycle and pedestrian network/transit stops/complete streets.
- 2) School Safety Initiatives (Safety Town Program, Safe Routes to School)
- 3) Bike Rack locations
- 4) Bike Friendly Business Initiative
- 5) Promotional Events

Staff is also reviewing the recommended actions and strategies identified in the 2011 Regional Thoroughfare and Pedestrian/Bicycle Plan and will provide an update to the BPAC members at the meeting on Tuesday.

**Regarding Recommendation for Preferred Bike Rack Locations
and Type/Style of Bike Racks**

Bike Racks Locations

Background:

At the July 12, 2016 BPAC meeting, KTMPO staff asked BPAC members to use the Bike/Ped Web Map to identify preferred locations of bike racks in the KTMPO planning region (Bell County, Southern Coryell County, and Eastern Lampasas County). This list will then go to the Central Texas Air Information and Research (CTAIR) Advisory Committee. CTAIR can then use BPAC recommendations to help determine locations for placing bike racks.

Action Item: Recommend locations of bike racks.

Bike Rack Style and Type

Background:

At the May 11th, 2016 BPAC meeting, BPAC members felt that the powder-coated wave-style bike rack was the best bike rack. After doing more research, KTMPO staff has security concerns with this style and would like to discuss this further with the BPAC members. Possible options are shown on the attached sheets.

Action Item: Recommend style/type of bike racks.

Bike Rack Overview

The Association of Pedestrian and Bicycle Professionals (APBP) bike rack criteria:

- Supports bike upright without putting stress on wheels—rack should provide two points of contact with frame
- Accommodates a variety of bicycles and attachments
- Allows locking of frame and at least one wheel with U-lock
- Provides security—not easy to cut or bend
- Intuitive—people know what it is and how to use it

Other considerations:

- Each bicycle parking space must be accessible without moving another bike
- Weather cover is a plus

Effective Bike Parking = Proximity to the Destination + Ease of Use

Bike Dock


- Also called Varsity Racks or Lighting Racks
- Bike docks allow for the front or back tire to be contained in a wheel trough while the frame and tire can be locked to the locking loop with a U-lock.
- Can be customized with logo
- Can accommodate two bikes
- 5 bike docks make up one bike corral*which could replace one standard sized parking spot. Will hold 10 bikes

Inverted U

- Also called Hoop Racks, A-Racks, Hoop Runner Racks
- Is intended for bikes to be parked parallel to the rack
- Square tubing is recommended as it resists cutting more so than round tubing
- Must consider tubing size or it can be too large to accommodate a U-lock
- Bikes can tip over if not locked properly
- A bike corral can accommodate 8 bikes

*Bike corrals are ideal in high density areas with small sidewalks and heavy pedestrian traffic. Several individual racks make up a corral. Corrals are often used to replace a vehicle parking space.


